		<p>are in place at all times.</p> <p><b>Children</b>  <a href="#">Children in clinically vulnerable and clinically extremely vulnerable health categories (as defined by PHE guidance)</a></p> <p><i>Most pupils in the “Clinically Extremely Vulnerable”- Most children <b>originally</b> identified as ‘clinically extremely vulnerable’ (CEV) no longer need to follow shielding advice as more evidence has emerged that shows there is a very low risk of children becoming very unwell from COVID-19, even for children with existing health conditions. Those children whose doctors have confirmed they are still CEV are not attending school when advised to do so by the Government during periods of national restrictions. Appropriate arrangements should be made so that education can continue at home. (with a small number of exceptions identified by the child’s consultant/GP) along with those children classed as “Clinically Vulnerable”. Outside of these times, for those pupils in the CEV category, an individual risk assessment has been carried out in consultation with the child’s parents and the relevant healthcare professional(s). Advice from health professionals/GP involved in the child’s care is essential in these circumstances.
